PLEASE READ THE FOLLOWING CONDITIONS CAREFULLY

- River Downs reserves the right to refuse this application for any reason or cause and also to refuse any entry without notice.
- FOR THIS APPLICATION TO BE CONSIDERED HORSE'S NAMES MUST BE SPELLED CORRECTLY AND CLEARLY.** Trainers are advised not to ship to River Downs until notified that stall(s) have been allotted to them. Horses allotted stall space from this application must conform with horses being shipped to River Downs. River Downs's management must be notified of any and all changes originally applied for. Any changes without notifying management could result in cancellation of your stall allotment. Horses duplicated and/or appearing on different applications or if rejected from another track will result in the cancellation of those applications. A trainer, van driver or groom must be aware of the identity of all horses in their charge, upon the arrival at the security gate.
- Horses' assigned stalls must not be moved from assigned stalls or barn without permission of the Racing Secretary. Horses appearing on any barred list will not be permitted on the grounds and will not be eligible to start without permission from the Starter.
- Failure to receive a rejection notification is not the responsibility of River Downs management. Should the meeting for which stalls have been allocated be, called off, or for any reason fail to be completed, the assigned stalls will automatically revert back to River Downs management.
- The undersigned understands that there are numerous hazards and risks of injury to themselves and to their property incidental to accepting stalls and participating in thoroughbred horse racing conducted by River Downs, and therefore it is agreed, as one of the inducements and material considerations for River Downs granting the undersigned a stall allotment and allowing the undersigned to race horses on the track operated by River Downs, that the undersigned for themselves, and for those on whose behalf horses are trained, assume risks of damages, to the extent permitted by law as a result of and arising out of accepting stalls and participating in thoroughbred horse racing at River Downs, and that the undersigned, for themselves and for those on whose behalf they train horses, their agents, employees and contractors providing services to the trainer, agent, and shall save and hold River Downs harmless for all damages, actions, causes of actions, claims, fees, costs and losses arising out of any loss, damage, or destruction of whatsoever kind, nature or description that may arise or be sustained by anyone which, under law of Ohio, imposes liability upon the undersigned as a result of any negligence, act or omission of the undersigned or any agent or employee of the undersigned, their agents or employees providing services to the trainer or agent.
- Owner and trainers will be held responsible for any and all misuse of stalls and/or tack rooms assigned to them, and for their employees and visitors at all times while on River Downs property.
- The Applicant for themselves and for those on whose behalf they train horses agree to abide by the rules and regulations of River Downs and to the terms and conditions of any agreement with the representative Horsemen's Association and to accept the decisions of the stewards of River Downs as final on all matters pertaining to racing.
- The management reserves all rights to radio, television, photography, motion picture, or videotape and related activities on River Downs' property or in any way connected with such activities taking place on River Downs property to the extent described in the agreement with the HBPA.
- The bona fide owner(s) of each horse listed must be named on this application.
- No horse will be permitted to start at River Downs unless each and every owner has a valid and current Ohio license.
- The controlled use of phenylbutazone (BUTE) and furosemide (LASIX) is permitted. See Ohio State Rules and Regulations for details.
- Upon arrival at River Downs all horses must be accompanied by a valid health certificate and negative coggins test within the past twelve (12) months.
- All horses racing in Ohio must be lip tattooed.
- All trainers agree to vacate all stalls and remove horses' equipment from River Downs's property upon request, within a reasonable time set by River Downs Management.
- ALL HORSES MUST BE ON THE GROUNDS FIVE (5) DAYS PRIOR TO EACH MEETING UNLESS OTHERWISE APPROVED BY THE RACING SECRETARY.**
- THIS STALL APPLICATION WILL BE YOUR OFFICIAL REGISTRATION; ANY AND ALL CHANGES MUST BE MADE UPON ARRIVAL.**
- THIS APPLICATION WILL NOT BE CONSIDERED UNLESS COMPLETED IN FULL.**
- Stall spaces for two-year-olds will be limited.
- During training hours, ONLY Trainers, Owners, Blacksmiths, Veterinarians, River Downs Officials, Security and Maintenances personnel are permitted in Barn area. No exceptions except by permission of the Racing Secretary only.**

Having read all the conditions on both sides of this application, I hereby apply for stable accommodations for the horses listed herein, and my acceptance of the stalls assigned to me shall be deemed my approval and agreement to abide by all the rules and regulations, present and future, of both Ohio State Racing Commission and River Downs.
